



# **School Parent and Family Engagement Policy**

Kalon Prep Academy is committed to the goal of providing quality education to every student enrolled at our school. We aim to establish partnerships with parents/guardians throughout the community. Everyone's opportunity to succeed increases when schools, students and families work together to promote high achievement.

## PART I. DISTRICT EXPECTATIONS

Kalon Prep Academy will include parents/guardians in the joint development of a district plan, including the review and improvement process. In the event that Kalop Prep Academy has been identified as needing improvement, the school will notify parents/guardians through our school newsletter and posted on our website.

Kalon Prep Academy will utilize a schoolwide Title I approach designed to upgrade the entirety of our educational program; its primary goal is to ensure that all students, particularly those who are low-achieving, demonstrate proficient and advanced levels on state academic achievement standards.

Kalon Prep Academy will include its students' parents/guardians in an organized, ongoing, and timely way in the planning, review, and improvement of these programs as

well as the school parent involvement plan.

- Parent Title I meetings will be held multiple times per year.
- ❖ Kalon Prep Academy's improvement plan is overseen by its School Improvement Committee, on which parent participation is sought. Notification of meetings is sent to parents/guardians via electronic newsletters.

Kalon Prep Academy will provide the following necessary coordination, technical assistance, and other support in planning and implementing effective parent involvement activities to improve student academic achievement and school performance.

Kalon Prep Academy will, with the assistance of its Title I schools, provide support to parents/guardians of children served by Kalon Prep Academy, as appropriate, in understanding topics such as the following.

  - ➤ The academic content standards are shared in the student/family handbook with each student family at the beginning of each year and upon new student enrollment. The content standards can also be accessed from the school's academic progress reporting system
  - ➤ The student achievement standards and assessments are included in the Annual Report published in October. The report is included on the school's website. ➤ The requirements of Title I are shared at the fall and spring meetings with parents/guardians.
  - > The community nights will provide ideas on how parents/guardians may monitor their child's progress, best practices for reading, and on issues like how to support mental health.
  - ➤ Kalon Prep Academy staff email addresses and contact information are available on the school's website. Written/verbal correspondence with families/parents/guardians are encouraged to contact staff with questions, comments or ideas.
  - > Kalon Prep Academy sends newsletters via traditional mail and email.

In order to support and educate parents/guardians regarding any of the above topics, Kalon Prep Academy will offer scheduled activities such as workshops, conferences, classes, including any equipment or other materials required to understand them.

If it is requested by parents/guardians of participating students, Kalon Prep Academy will provide opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions related to the education of their children, and respond to any such suggestions as soon as practically possible.

- The survey results will also be shared with the Board of Directors and all school staff.

Kalon Prep Academy will hold an annual meeting at a time convenient to most parents/guardians, who shall be invited and encouraged to attend, in order to inform those parents/guardians of their school's participation under this part and to explain the requirements of this part, and the right of the parents/guardians to be involved.

Kalon Prep Academy will involve parents/guardians in the decisions regarding how funds are reserved for parental involvement activities.
